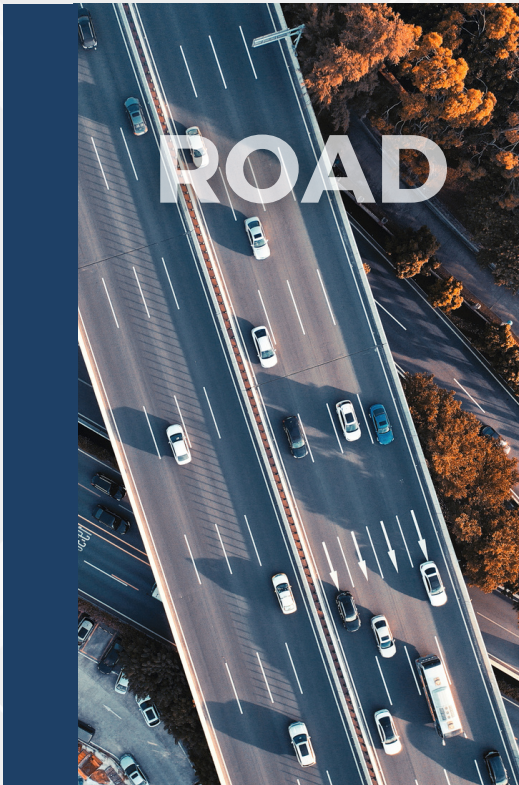

PACTS events



PACTS typically organises:

- **Two one-day conferences each year (spring and autumn);**
- **The prestigious annual [Westminster Transport Safety Lecture](#);**
- **A joint Working Party meeting each year; and**
- **Various parliamentary briefings and report launch events.**

PACTS events are content-rich and provide thought-leadership. Speakers are selected for their expertise, relevance and speaking qualities. Programmes are carefully structured to combine technical and policy aspects, public and private sector inputs and to provide delegates with opportunities to contribute to the debates and for networking. A Government minister often gives the keynote speech. PACTS strives to achieve diversity in speakers and participants.

The conferences are usually held in central London with a hybrid facility and the annual Westminster Lecture for Transport Safety is held in person, and whenever possible in the Palace of Westminster (Houses of Parliament). Other events are usually held in Westminster.

Who attends PACTS events?

Recent PACTS conferences and Westminster Lectures have attracted some 100-150 delegates and speakers. Those attending PACTS events are typically influential decision-makers within their organisations both in the public and private sector.

We attract a broad range of attendees including MPs, civil servants, transport professionals, contractors, local authority officers, police chiefs, health service providers, insurers, technology providers, researchers, road user group representatives and others.
